RENT TO OWN NEW AND USED INSTRUMENTS:

- 1) **No instruments rented without a valid major credit card or check/debit card information; current card # must be on file.**
- 2) All instruments must be rented for a minimum of two (2) months.
- 3) Instruments may be rented to own with a down payment (same as monthly payment) and then 24 monthly payments.
- 4) The renter may purchase the instrument in one (1) payment by taking a 20% discount off the remaining balance.
- 5) After the final rent payment is made, the instrument becomes property of the renter.
- 6) You will receive a payment book and all payments made apply toward purchases.
- 7) The instrument may be returned to BANDLAND at any time, with no further obligation, provided the payments are current.
- 8) The renter must notify BANDLAND of any changes of home address, school, or if you want to return the instrument.
- 9) If the instrument is lost, stolen, abused and /or destroyed, the renter is responsible for payments in full of any outstanding balance.
- 10) Late charges of \$5.00 will be assessed to each payment received after 10 days from the due date.
- 11) Free maintenance and warranty work on the rented instrument can only be performed by BANDLAND or the manufacturer.
- 12) In the event of default on any rent payment due, BANDLAND may take possession of the listed instrument wherever the same may be found without notice to the renter, without liability to the lessor, and without prejudice to any legal remedies of BANDLAND.
 In the event BANDLAND turns the matter of collection of the amount owed hereunder and/or repossession of the instrument over to an attorney and/or collection agency, then BANDLAND shall be entitled to its reasonable attorney fee and collection costs.

BANDLAND MAINTENANCE AGREEMENT

The Maintenance Agreement with BANDLAND covers the services below

ITEMS OF SERVICE

- 1) Labor charges to restore the instrument to proper playing condition when out of adjustment due to ordinary wear.
- 2) Cost of supplies such as corks, pads, felts and springs.
- 3) Labor charges for the following are included when damages are by ordinary wear. Removing of stuck mouthpieces, soldering broken braces, pulling stuck slides, valve repair, trombone hand slide repair, and dent work on any metal instrument which is serious enough to cause the instrument to play improperly.

ITEMS NOT COVERED

- 1) The replacement of parts on woodwind or brass instruments that are damaged beyond repair.
- 2) This Agreement does not cover the loss, theft, or destruction of the leased instruments.
- 3) Restoration of finished or replacement of expendable accessories such as lubricants, reeds, straps or mouthpieces.

In the event of default on any rent payment due, BANDLAND may take possession of the listed instrument whenever the same may be found without notice to the renter, without liability to the lessor, and without prejudice to any legal remedies of BANDLAND. In the event BANDLAND turns the matter of collection of the amount owed hereunder and/or repossession of the instrument over to an attorney and/or collection agency, the BANDLAND shall be entitled to its reasonable attorney fees and collection costs.
